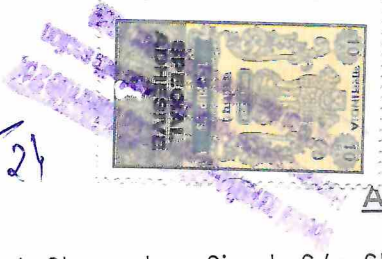

Through Special Leave to Appeal (C) No.20307-2023-Jan  
Kalyan Trust and another Vs. Registrar General of Societies, Haryana and  
others, an interim order of this Court dated 07.08.2023 was challenged before  
the Supreme Court. The said petition was disposed of by the Supreme Court  
on 28.11.2023 through the following order:-

- “1. We are not inclined to interfere in the present petition.
2. Both the parties agree that during the pendency of the proceedings before the High Court, an independent Administrator could be appointed to manage the affairs of the Trust.
3. The special leave petition is, accordingly, disposed of.

CM-1777-LPA-2020 in LPA-1289-2016 and other connected cases -2-

4. *The High Court is requested to appoint an independent Administrator till such period as it deems necessary.*
5. *Needless to state that we have not considered as regard to any finding about the conduct of Shri Raheja.*
6. *Needless also to state that the petitioner would be at liberty to raise the contention with regard to outer limit of the period during which the Administrator could be appointed”.*

In terms of the afore quoted order of the Supreme Court, to administer the society, we appoint Dr. Shamsheer Singh, Principal (Retd.) Govt. College, Bhiwani, R/o H. No.175, Sector 1, Rohtak, as the new Administrator. Initially, the appointment shall be for a period of three months. The newly appointed Administrator shall be paid Rs.75,000/- per month which expenses shall be borne by the society.

Mr. DC Raheja, is directed to handover all records/charge to Dr. Shamsheer Singh.

For arguments, the hearing of the appeal is deferred to 24.01.2024.
